Wild Country Charity Hunt Information

This being our first year hosting this event, we are limited currently to children who can walk to the blind however we hope to make this an annual event and to be able to accommodate handicapped children. Due to the sizes of the blinds only the mentor and child will be allowed in the blind however the parent can ride with a Representative from Wild Country to drop off the mentor and child and can ride back to the blind to pick up the child.

Parents must have a background check and references. Children must be 10 by the day of the hunt and cannot be over 13 the day of the hunt.

All applications must be into Wild Country by Nov 30th, 2024, a live drawing will be held on Dec 2nd, 2024. A Birth Certificate is required for all children participating in this Hunt and the Adult accompanying them must provide an ID. The Adult must be parent or legal guardian and must provide a copy legal documentation if legal guardian.

Please arrive by 2 p.m. on Jan 24th, 2025, early arrival is recommended. Participants sign in will start at 2:30 p.m., orientation, meet and greet with target practice with Game Wardens from Mississippi Department of Wildlife, Fish and Parks. Room assignments, meet your guide and will follow.

Dinner on Friday will be from 6-630 p.m. with White Tails Unlimited and Brian Kittrell our WTU sponsor.

ON Jan 25th, 2025, your day will start with breakfast at 5 a.m. morning hunt will start at Daylight til Mid morning. Return to Wild Country to clean any game that is harvested, and lunch will be served at 12 p.m. Departure for evening hunt will be at 2:30 p.m. for the ones that didn't harvest an animal. Return from hunting around 7 p.m. and dinner will be served.

WAIVER AND RELEASE AGREEMENT

Please read carefully before signing. This is a release of liability and waiver of certain legal rights.

In consideration for my being permitted to participate in the activities of Wild Country Charity Hunt/Wild Country Offroad, I agree to the following Waiver and Release:

I acknowledge that outdoor activity has inherent risks, hazards, and dangers for anyone that cannot be eliminated particularly in a wilderness environment. I UNDERSTAND THAT THESE RISKS, HAZARDS AND DANGERS INCLUDE WITHOUT LIMITATION.

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of injury from ammunition and shot from other guns.
3. Walking in rugged country, including encounters with wildlife, animals, and insects.
4. Inclement weather conditions.
5. The risk of injury from riding on all all-terrain vehicles (ATV) or any vehicle used off the paved road. The risk of injury from the use of tree stands.
6. The risk of injury due to being around water (ponds when fishing).

I understand the risks, hazards, and dangers as described above and have had the opportunity to discuss them with a representative of Wild Country Charity Hunt/Wild Country Offroad. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate, and I elect to participate despite the risks.

I AM VOLUNTARILY USING THE SERVICES Wild Country Charity Hunt/Wild Country Offroad WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARD AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS OR DEATH.
